# MECHANICAL PERMIT INFORMATION

*Construction or work for which this permit is required shall be subject to inspection by the Code Official and such construction or work shall remain accessible and exposed for the purpose of inspection until approved.*

- **A final inspection is required on this permit** prior to any equipment being placed into operation, and it **shall** be the Contractor/Owner's responsibility to coordinate entry for that purpose.
- **The current rate for reinspection is \$80.00**
- **Permits are valid for (180) days** from the date of issuance, provided that an inspection takes place within that timeframe, after (180) days, a renewal is required for each additional (180) days, at a rate of \$40.00.
- **Chimneys** must be three (3) feet above any structure within ten (10) feet, and provided with a cleanout at the base.
- **Switch for shutoff must be installed adjacent to furnace.**
- **LP Gas regulators** shall not be placed within three (3) feet of any opening.
- **All approved appliances** shall be installed in accordance with the manufacturer's specifications, and installation specifications shall be on the job site when inspections take place.
- **Combustion and ventilation air** shall be provided for the structure
- **All exhaust fans** shall be vented to atmosphere in approved metal pipe
- **Solid fuel appliances** must be installed according to Manufacture's specification or State of Michigan Mechanical Code and shall have a UL label or the label of a recognized testing agency. Two (2) inspections are required, rough & final.
