Discussion was held on the easement that is to be moved by DTE, for the upcoming hangar project. Kamax updates.

# **NEW BUSINESS:**

Chairman Cronin stated to the board that the bids were opened and asked Vice Chairman Skylis to give an overview of the documents. Discussion was held.

There were four bidders for the proposed project and DCC Construction was the low bidder. It was stated that the project would be using the 2015, 2016, 2017 allocation money, but the project could start earlier if the Airport would cover the 2018 portion of the money until it was dispersed (later in August or September). The Finance committee and MDOT AERO could have a possible start date of June/July 2018. Discussion was held on steel prices.

Motion by Skylis, seconded by Zimmerman, <u>PASSED</u>, to recommend that the Mayfield Township Board accept the bid from DCC Construction for the construction of the Airport hangars, subject to MDOT authorizing the reimbursement of the 2018 allocation dollars to the airport. All ayes. 3 absent. Carried.

Budget workshop was held.

It was the consensus of the Board to cancel the April Airport meeting. The budget will be finalized at the May meeting.

Discussion was held on the underground storage tanks.
