

MAYFIELD TOWNSHIP BOARD MEETING  
MARCH 11, 2019

The regular meeting of the Mayfield Township Board was called to order at the Mayfield Township Hall, at 5:30 p.m. with the Pledge of Allegiance of the United States of America, by the Supervisor Dianna L. Ireland.

Motion by Frisch, seconded by Knowlton, **PASSED**, to waive the reading of the minutes of the February 11, 2018 regular meeting and approve them. All ayes. One nay. Carried.

Motion by Knowlton, seconded by Engelman, **PASSED**, to waive the reading of the February 2019 Treasurer's report and receive it into the record. All ayes. Carried. (Copy attached).

Public Time:

A property owner inquired about a fire run on Millville Road, it was stated that it would be looked into and that vacant land is a \$1500.00 charge.

A resident stated her disappointment with the ZBA and P.C. on how the dragstrip issue was handled. She stated that is non conforming and referred to the current ordinance and that the changes are sending a bad message to the public.

A resident discussed concerns about the containers that the dragstrip will be using being bug infested.

A resident stated that the P.C. and the ZBA were disappointing because of the size of the bleachers, parking, traffic.

County Commissioners Lenny Schneider and Dyle Henning stated that there have been solicitations from law firms, opiate crisis, class action suit against large pharmaceuticals.

Motion by Schlaud, seconded by Engelman, **PASSED**, to rezone the Robert Thomas Properties, Property ID# 44-014-031-003-10, from OS-1 back to R-2. Roll call vote: Schlaud-aye, Knowlton-aye, Engelman-aye, Ireland-aye, Frisch-aye. Carried.

Motion by Schlaud, seconded by Engelman, **PASSED**, to approve the Dust control agreement (Project # 504-014-194300) with Lapeer Co. Road Commission for up to 3 applications in the amount of \$3,676.00 per application. All ayes. Carried.

Motion by Schlaud, seconded by Knowlton, **PASSED**, to approve the Road Project Agreement with Lapeer Co. Road Commission for the Brush Axe and Tree Removal of Various Roads with the cost of \$10,000.00, \$5,000.00 allocation and \$5,000.00 township. All ayes. Carried.

Motion by Engelman, seconded by Frisch, **PASSED**, to approve the Road Side Mowing Contract with Lapeer Co. Road Commission, to do a double swath in the Spring and the Fall at a cost of \$4,500.00 per mowing. All ayes. One nay. Carried.

Motion by Frisch, seconded by Schlaud, **PASSED**, to approve the ditching of various roads project #504-014-194303 at a cost of \$10,000.00 with \$5,000.00 of allocation and \$5,000.00 to the township. All ayes. Carried.

Motion by Knowlton, seconded by Engelman, **PASSED**, to approve the budget amendments as presented. All ayes. Carried.

Trustee Engelman gave report on GLTA, ZBA.

Trustee Schlaud gave report on Planning Commission, EMS, CCA.

Motion by Frisch, seconded by Schlaud, **PASSED**, to adjourn. All ayes. Carried.
