Airport Board Chairman, Frank Thorman presented an award for Airport Manager of the Year to Ron Keil, the Lapeer Dupont Airport Manager,

Motion by Knowlton, seconded by Engelman, <u>PASSED</u>, to waive the reading of the minutes of the September 12, 2016 regular meeting and approve them. All ayes. Carried.

No Treasurer report was received.

Brad Haggadone introduced himself to the board as a candidate for Lapeer Community Schools.

John Miller stated to the board that he would be going into private practice and would like to be considered as possible legal council for Mayfield Township.

Lt. Andy Engster stated to the board that Dep. Jennifer Byrd would be starting the night shift at the township later this month.

Trustee Knowlton inquired about the breakins.

Motion by Frisch, seconded by Knowlton, <u>PASSED</u>, to approve the budget amendments as presented. All ayes. Carried.

Discussion was held on a new sign for the township. Township will check for quotes.

Motion by Schlaud, seconded by Engelman, <u>PASSED</u>, to approve the Property Tax Remittance Agreement with Lapeer Community Schools and Mayfield Township and allow the Treasurer to sign. All ayes. Carried.

Trustee Knowlton stated that the Clerk had called MTA and she was told that she could only put it on the record that she voted nay on the 8-30-16 raise that was approved.
